The total number of section of the school shall be restricted to 18 and further increase of section shall be subject to specific approval of the Board on the basis of

the request of the school as per Affiliation Bye Laws and subject to the availability of room size of greater than 500 sq ft. As per data filled by the school, there are 1 building block, however, there are multiple 2 building blocks are seen in the IC video. The school is directed to dismantle the shed inside the campus immediately as mentioned undertaking and construct a partition to separate the old building which to be used for staff quarter as mentioned undertaking and submit the compliance within 3 months on SARAS portal. As reported by the school, there are CWSN toilets one each for boys and girls. The 3 school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage and submit the compliance within 3 months on SARAS portal. Circular No. 05/2023 may be referred to for CWSN facilities. The library is seen as under stocked.no separate reading area for staff is seen.the 4 school shall upgrade the library as per SoP issued by the Board within 3 months and submit compliance on SARAS. As per IC report, the Head of sexual harassment committee is male person. The 5 school is directed to replace the committee head with a female person from its faculty list and submit the compliance within next 3 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/-every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The school shall conduct training of its teachers with CoE Vijaywada within 3 months

- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
